6. Reports of Officers:

- a) Treasurer's Report: Financial Statement for 2024 Reviewed the report presented by Keith (attached) Expenditures within the projected budgeted amounts and ended up with approx. \$1000.00 surplus for 2024 which gets added to operating account
 - Insurance (\$7500.00) the largest expenditure and about half of the budget
- b) Vice President's Report Membership finished 2024 with 1044 members; up to approximately 550 and growing for 2025. Busy at the PGOSA table on Wednesday mornings lots of new members joining as heard positives about our group.

Activities – all happening, new pickleball group proposed for February

7. Report of Directors:

a) Rodney Arnold- worked on Community Park permits for the spring – summer membership table and for the pancake breakfasts and picnic. Closer to May will need to get park keys and parking permit for one vehicle – drop off supplies

- b) Doug Williams talked about "Friends" program and possible new company that is tech/electronics. Has done reference checks all positive so bring on board.
- Also Ricky's and Shady Rest interested in our "Friends" program – Jim will pursue with owner/manager
- c) David White not present for meeting but his assistance with "Games and Cards" is appreciated

8. New Business:

- a) Friends of PGOSA Doug has spoken to many of our "Friends" and makes sure they get our newsletter. They are supportive and some well used by members.
- b) Proposal for new Friend electronics/technology. All in favor of bringing them on board
- c) Expanding Pickleball for beginners Jim working with a member to start another group which will be for Novices. Need to secure gym time at OMS and advertise in the Chronicle – not for the Tuesday more advanced group members
- d New Activities this Year- Dance Club, Lawn Bowling, Wood Carving- going ahead and need to support with funds and assistance so they will flourish. Lawn Bowling to start up in May and will promote using a "stick" for those with mobility issues (like curling with a stick)
- e) Activities Update Request from Paddlers; they want to buy a set of 2 or 3 walkie-talkies which are water proof for their paddles. Allows conversation between lead kayak and sweep possible which is great for safety
 - f) Recruitment of Board Directors/Executive April /25 We need more Help/assistance at the Board level – Jim, at times is overloaded with many tasks but all are

necessary to keep PGOSA thriving. AGM coming in April so keep eyes/ears open for members who would assist with Admin functions
